Deputy Mayor Gratto opened the meeting at 7:00 pm.

Mr. Paul Bishop was in attendance to review with the board and guest the steps of procedure to get the Consolidation Study under way.

Details discussed included a time frame of possibly 3-5 months, dissolution committee to be formed of residents of both village and town, board/employees, include both people for/against/and with no favor. It will be up to the Town board to determine if services will be included in the town or set up into a district. These areas include sidewalk maintenance/plowing, street lights, water, sewer, etc. There will be a website created by CGR to post information as it is compiled for the public to access. Budgets will be compared. There will be a public meeting after all information is compiled.

Board reviewed contract submitted by CGR. The board thanked Mr. Bishop for attending and clarifying details.
